## AMENDING AND APPROVING THE KAYENTA CHAPTER FY2025 INTO FY2026 CARRYOVER BUDGET MODIFICATION TOTALING \$2,577,127.56.

#### WHEREAS,

- 1. Pursuant to 26 N.N.C., Section 3(A), the Kayenta Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1(B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. Pursuant to the Kayenta Chapter Resolution No. KT-06-112-10, The Kayenta Chapter approved the Five Management System (FMS) for use by the Kayenta Chapter in the lawful management of the Chapter as directed by the Navajo Department of Justice and Office of Auditor General; and
- 4. Pursuant to the Kayenta Chapter Resolution No. KY26-10-001, the Kayenta Chapter approved the Kayenta Chapter's FY2025 into FY2026 Carryover Budget totaling \$2,590,468.35; and
- 5. Pursuant to the Kayenta Chapter Five Management System- Fiscal Policy, it shall be the Kayenta Chapter's policy that no expenditures of Kayenta Chapter funds shall be made without an approved annual budget and that no expenditures shall exceed the budgeted amounts without prior approval by the Kayenta Chapter voting members; and
- 6. Per the FY2026 Budget Instruction Manual, the Kayenta Chapter shall maintain a file containing all the laws, regulations, policies, fund management plans, and plans of operations referenced in the Chapter Budget Policies; and
- 7. Funds appropriated by the Navajo Nation Council are to be maintained in separate budgets or accounts, and those funds cannot be commingled; and
- 8. Pursuant to the Kayenta Chapter Five Management System-Fiscal Policy, the approved Kayenta Chapter operating budget may also include funds other than Navajo Nation appropriated funds, as well as carryover of the previous fiscal year's unexpended funds, except where the funding agency(s) do not permit the carryover of funds; and
- 9. The Kayenta Chapter Administration, in consultation with the Kayenta Chapter Officials, has reviewed and made recommendations for the Kayenta Chapter FY2025 into FY2026 Carryover budget.

10. The Kayenta Chapter Administration had to account for the last 7 days of September 2025 for payroll, which was paid out on October 14, 2025 which provided a correct number and accrual adjustments in Fund 02 and Fund 15.

## NOW THEREFORE BE IT RESOLVED THAT:

The Kayenta Chapter hereby approves the Kayenta Chapter FY2025 into FY2026 Carryover budget modification totaling \$2,577,127.56 attached as Exhibit "A".

THIS AGREEMENT is made as of August 19, 2025 ("Effective Date") by and between Navajo County, Arizona ("County"), and the following recipient of funds ("Recipient"):

Nature of Recipient's Organization (public agency, nonprofit corporation, 501(c)(3) organization, etc.: Chapter Senior Center, Public assistance for services to disabled persons or persons 60 years of age or older.

WHEREAS, Section 11-267 of the Arizona Revised Statutes provides as follows:

- A. Any county may implement programs to provide services to disabled persons or persons sixty years of age or older, and may contract with federal, state, local or other providers for the provision of these services.
- B. As used in this section, "services" may include, but not be limited to, nursing care, sheltered care, day care, home maintenance, housekeeping, transportation and nutrition services.

WHEREAS, pursuant to A.R.S. § 11-267, County is awarding to Recipient funds in the amount of \$ 2,000.00 (the "Funds") to be used solely for services to disabled persons or persons 60 years of age or older; and

WHEREAS, County's award of the Funds and Recipient's receipt and use of the Funds are subject to the terms and conditions of this Agreement,

NOW, THEREFORE, the parties hereby agree as follows:

1. Upon the approval of this Agreement by the Navajo County Board of Supervisors, County shall pay to Recipient the Funds in the amount of \$2,000.00.

- b. Recipient shall keep accurate and complete records pertaining to its use of the Funds during the term of this Agreement and for a period of five years thereafter. Recipient's books and records pertaining to its use of the Funds are subject to inspection and audit by County, its authorized representative, or a representative of the Arizona Auditor General's Office upon reasonable notice to Recipient. If any such inspection or audit discloses that the Funds or any portion thereof have been used for purposes other than those permitted by A.R.S. § 11-267 and this Agreement, the amount so misused shall be immediately reimbursed to County and County shall have all other legal and equitable remedies (including without limitation the disqualification of Recipient for all future awards).
- c. Recipients shall cash the check within the same fiscal year of County in which it was awarded, or the check will be void.
- d. The Funds shall be expended by Recipient during the fiscal year of County in which they are awarded. Any unexpended Funds as of the close of such fiscal year (June 30) shall be returned to County.
- e. Recipient shall maintain in force commercial general liability insurance appropriate for its operations and shall indemnify, defend and hold harmless County from and against any and all claims, actions, losses or liabilities arising out of Recipient's receipt or use of the Funds.

# KAYENTA CHAPTER FUND MANAGEMENT PLAN CHAPTER-ACTIVITIES GENERAL FUND ACCOUNT-FUND 01

#### I. ESTABLISHMENT

The Kayenta Chapter establishes the Chapter Activities General Fund, commonly known as Fund 01, within the Kayenta Chapter's Chart of Accounts. This fund management plan establishes the criteria for the revenue and expenditure of the Chapter Activities Fund account

#### **PURPOSE**

The purpose of the Chapter Activities General Fund (01) is to provide funds for expenditures of the Kayenta Chapter's operating supplies, purchase food for meetings, bank service charges, and any other spending as listed in the Kayenta Chapter's chart of accounts.

#### II. AUTHORIZATION

- a. Pursuant to 26 N.N.C. Section 101(A), the Kayenta Chapter is operating under the Five Management System (FMS) to ensure fiscal accountability from the Chapter Administration, and has developed the Kayenta Chapter Fund Management Plan for the Chapter Activities General Fund, Fund 01, to provide guidelines for the Kayenta Chapter administration to administer the Fund 01 account.
- b. Pursuant to the Kayenta Chapter Resolution No KY22-105-05, the Kayenta Chapter's Fund Management Plan is hereby approved and adopted on May 13, 2022.
- c. Pursuant to the Kayenta Chapter Resolution No. KY25-05-015, the Kayenta Chapter's Fund Management Plan has been reviewed and amended for approval.
- d. Pursuant to the Kayenta Chapter Resolution No. KY26-10-010, the Kayenta Chapter's Fund Management Plan has been reviewed and approved for amendments.

#### III. ADMINISTRATION AND EXPENDITURES

- a. The funding sources of this Fund 01 shall be revenue generated from the use of the Kayenta Chapter facilities, services, equipment, and donations received.
- b. The Kayenta Chapter Administration shall be responsible for the administration of the use and expenditure of the Chapter Activities General Fund (Fund 01) for the purposes intended for the benefit of the Kayenta Chapter community members.
- c. The Kayenta Chapter shall comply with the Chapter's Five Management System to ensure fiscal accountability.

#### IV. DISTRIBUTION AND BUDGETING OF ACTUAL REVENUES

- a. The Kayenta Chapter administration shall record all revenues received and shall deposit them into the Kayenta Chapter's checking account. The revenues deposited shall be budgeted in accordance with the allocation and budgeting of revenues received.
- b. Funds budgeted shall be made available to utilize until after the closing of the month-end.
- c. The Kayenta Chapter administration, in consultation with the Kayenta Chapter Officials, shall determine if needed, reallocate funds to other GL Codes, but this shall only apply to the revenues received at the chapter.

## V. ALLOCATION AND BUDGETING OF REVENUES RECEIVED

- a. All revenues received in the Kayenta Chapter Activities General Fund (Fund 01) shall be distributed as follows:
  - i. Funds received get allocated into the following GL Codes
    - 1. Financial Assistance-Funerals- 55%
    - 2. Gasoline-Vehicle-15%
    - 3. Diesel Fuel- 15%
    - 4. Repairs & Maintenance- 5%

- 5. Operating Supplies- 5%
- 6. Food Purchases- 5%

## VI. REPORTING OF REVENUES AND EXPENDITURES RECEIVED

**a.** The Kayenta Chapter shall report all revenues and expenditures in the Chapter Fund Chapter Activities Account as part of the Chapter Secretary/Treasurer's monthly financial report.

## VII. FUND MANAGEMENT PLAN DURATION

a. The Fund Management Plan for the Kayenta Chapter Activities General Fund (Fund 01) shall exist until terminated by the Kayenta Chapter.

## VIII. AMENDMENTS

a. The Fund Management Plan for the Chapter Activities General Fund (01) for the Kayenta Chapter may be amended by the Chapter based upon the recommendation of the Chapter Manager in coordination and consultation with the Kayenta Chapter Officials, and approved by Chapter membership, at a duly called Kayenta Chapter meeting.

## IX. COMPLIANCE

a. The Kayenta Chapter shall comply with the Five Management System Policies and Procedures for Procurement, Fiscal, Records, Personnel, and Property.

APPROVING "NO CONFIDENCE" IN BUU NYGREN AS PRESIDENT AND RICHELLE MONTOYA AS VICE PRESIDENT OF THE NAVAJO NATION AND REQUESTING THE NAVAJO NATION COUNCIL TO REMOVE OR PLACE BUU NYGREN AND RICHELLE MONTOYA ON ADMINISTRATIVE LEAVE FOR JUST AND GOOD CAUSE PURSUANT TO TITLE 11, SUBCHAPTER 13 §240 (REMOVAL/ADMINISTRATIVE LEAVE) AND TITLE 2, CHAPTER 6 §3741 (ETHICS IN GOVERNMENTAL LAW).

#### **WHEREAS:**

- 1. Pursuant to 26 N.N.C., Section 2(A), the Kayenat Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed as 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1 (B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. Kayenta Chapter is dedicated to the safety and well-being of community members and the objective to ensure sharing of information and providing an understanding of community events, projects and initiatives responsive to the needs of the children, elders, veterans and families; and
- 4. Kayenta Chapter submits this formal argument of No Confidence in Buu Nygren as President and Richelle Montoya as Vice President and seeks to address serious concerns regarding alleged misconduct, mismanagement and abuse of authority within the Office of the President and Vice President; and
- 5. In light of the gravity of these allegations, Kayenta Chapter request the Navajo Nation Council to remove or place both officials on administrative leave pursuant to Navajo Nation laws and allow for a fair and thorough investigation; and
- 6. The alleged allegations of sexual harassment by the Vice President against the President was not properly investigated and the investigation was flawed by undo influence by the President and such allegations, if substantiated, represent a severe breach of ethical conduct and workplace safety, necessitate immediate investigation unhindered by the presence of either party in office; and
- 7. The mismanagement and loss of \$24 million intended for Navajo homes, involving Zenni Homes and Indigenous Design Studio and Architects (IDSA) which is not in any Navajo Nation accounts contrary to the Presidents statements that the funds are secured a Navajo Nation account; and
- 8. The management style and decisions of the Nygren/Montoya Administration have had a detrimental effect on the Navajo government and a negative impact on individuals, families, communities and chapter governmental operation throughout the Navajo Nation, these cumulative concerns provide just and good cause for requesting removal or administrative leave; and
- 9. Given the severity and extent of these issues, immediate intervention is warranted to prevent further harm, to restore trust in the leadership of the Navajo Nation and the continuation of such conduct poses significant risks to the Navajo Nation's reputation, financial stability and overall

- morale and it is essential decisive action be taken to address these violations and uphold the standards expected of public officials; the Navajo Nation President and Vice President; and
- 10. Kayenta Chapter further recognizes the importance of an efficient, effective and ethical government in upholding Diné justice, traditions, and the rule of law is necessary to protect the rights and safety of Navajo citizens.

## NOW THEREFORE BE IT RESOLVED THAT:

- 1. Kayenta Chapter hereby approves "No Confidence" in Buu Nygren as President of the Navajo Nation and requesting the Navajo Nation Council to remove or place Buu Nygren on Administrative Leave for just and good cause pursuant to Title 11, Subchapter 13 §240 (Removal/Administrative Leave) and Title 2, Chapter 6 §3741 (Ethics in Governmental Law).
- 2. Kayenta Chapter hereby approves "No Confidence" in Richelle Montoya as Vice President of the Navajo Nation and requesting the Navajo Nation Council to remove or place Richelle Montoya on Administrative Leave for just and good cause pursuant to Title 11, Subchapter 13 §240 (Removal/Administrative Leave) and Title 2, Chapter 6 §3741 (Ethics in Governmental Law).
- 3. Kayenta Chapter further expresses that it does not take this action lightly or without reservation but the management of the Nygren/Montoya Administration by the President and Vice President has negatively impacted individuals, families, communities, the Navajo Nation and Chapter governmental operations which provides for the just and good cause for this action as follows:
  - Abuse of Authority, Abuse of Office, Neglect of Duties.
  - Misuse & Mismanagement of Navajo Nation Funds.
  - Failure to abide by policies, procedures & standards adopted.
  - Creating Hostile Work Environments.
  - Creating Discord leading to decreased productivity.
  - Failure to treat Navajo Nation employees with courtesy.
  - Unsatisfactory Work Performance.
  - Creating Fraud, Waste and Abuse that lead to unnecessary cost or poor value:
  - Intentional Deception (Fraud),
  - Careless or inefficient use of Resources (Waste)
  - Improper or unreasonable practices (Abuse)
  - Actions detrimental to the Navajo Nation; its operations & its people.
  - Egregious misconduct which calls into question one's fitness for office.
- 4. Kayenta Chapter hereby believes that in order for proper investigations of alleged misconduct the President and Vice President must be placed on administrative leave or removed from office so a fair, unbiased and unintimidated investigation may be conducted.
- 5. Kayenta Chapter asserts that these actions are necessary to protect the interest of the Navajo Nation, its people and to ensure a fair and thorough investigation into all allegations and misconduct. We urge the Navajo Nation Council to act promptly and decisively in response to these grave concerns, upholding the principles of accountability, transparency and ethical governance for the benefit of all Navajo people.

#### WHEREAS,

- 1. Pursuant to 26 N.N.C., Section 3(A), the Kayenta Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1 (B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. The 25<sup>th</sup> Navajo Nation Council approved resolution CS-44-25, the Fiscal Year 2026 Comprehensive Budget on September 4, 2025, which was later line-item vetoed by the Navajo Nation President Buu Nygren on September 15, 2025, resulting in the removal of \$22,833,129 from the budget; and
- 4. Among the line-item vetoes were significant cuts to the Legislative Branch, including reductions to personnel funding, which has jeopardized operations and resulted in the loss of 28 positions essential to serving the Navajo people; and
- 5. The Judicial Branch was also severely impacted, limiting its ability to provide court services, peacemaking, probation, and judicial oversight, which are critical to maintaining justice and order across the Navajo Nation; and
- 6. Legislation No. 0219-25 was introduced to amend resolution CS-44-25 and restore critical funding to both the Legislative Branch, in the amount of \$8,100,263, and the Judicial Branch, in the amount of \$941,732, thereby ensuring stability, continuity of services, and restoration of personnel; and
- 7. The Kayenta Chapter recognizes that the Legislative Branch is an essential part of the government structure and is the direct voice of the Navajo people; that restoring funding, including the 28 personnel positions, is vital for effective representation, community services, and government accountability; and
- 8. The Kayenta Chapter further recognizes the importance of the Judicial Branch in upholding Diné justice, traditions, and the rule of law, and that full funding is necessary to protect the rights and safety of Navajo citizens.

### WHEREAS,

- 1. Pursuant to 26 N.N.C., Section 3(A), the Kayenta Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1 (B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. The Chapter governs and serves in accordance with the Diné Principles of Sa'ah Naagháí Bik'eh Hózhóón, upholding; and harmony, balance and sacred responsible to the Diné People; and

The Chapter calls for unified action by the Budgeting and Finance Committee, the 25<sup>th</sup> Navajo Nation Council, the Office of the Speaker, the Office of the President and Vice President, and all the relevant executive officials to finalize and enact a Comprehensive Budget prior to the start of FY 2026; and

The Navajo Nation Procurement Act (12 N.N.C. § 301 et.seq.) outlines that oversight authorities—including the Attorney General and Chief Justice—shall not participate in procurement and fiscal decision-making where there may be a conflict of interest or a violation of the separation of powers; and

SUPPORTING THE REQUEST TO THE NAVAJO NATION DEPARTMENT OF TRANSPORTATION AND THE BUREAU OF INDIAN AFFAIRS ROADS DEPARTMENT TO REHABILITATE NAVAJO ROUTE 59 BETWEEN MILEPOST 16 TO HIGHWAY 160.

## WHEREAS,

- 1. Pursuant to 26 N.N.C., Section 3(A), the Kayenta Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1 (B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. The Kayenta Chapter is completely aware of the roadway conditions on the Navajo Route 59 between Highway 160 and Rough Rock. The chapter has a crisscross of school bus routes from Rough Rock Community School, Kayenta Unified School District, Kayenta Boarding School, and the Chilchinbeto Community School. Poor road conditions significantly impact students' attendance, performance, and dropout rates, limiting their educational opportunities and outcomes, as the 2017 U.S. Government Accountability Office reported. In February of 2022, the Northern Arizona Council of Government (NACOG) was instructed to perform its studies. The chapter further understands that transportation challenges can lead to increased absenteeism, lower academic performance, and higher dropout rates among rural students; and
- 4. The Kayenta Chapter request that the NR 59 be assessed and included in the rehabilitation of the route because it is the main corridor used by many of our students, residents, and visitors and it's the shortest route to Window Rock and other places. It is a main route that tourists, local residents, commuters, commercial trucks, and emergency transports use daily year-round; and
- 5. This pivotal road runs along the Black Mesa region. The area receives heavy snow and runoffs that adversely affect the pavement. Some of the distresses and failures that are occurring are (1) block cracking, (2) longitude cracking, (3) edge cracking, (4) slippage cracks, (5) potholes, (6) depression, (7) rutting and shoving, (8) upheaval and raveling, (9) undercutting by improper use of equipment on the shoulder, and (10) deep dips in a couple of areas. All these defects make the route unsafe, and it must be rehabilitated.

#### NOW THEREFORE BE IT RESOLVED THAT:

The Kayenta Chapter hereby supports the requests to the Navajo Department of Transportation and the Bureau of Indian Affairs Roads Department to perform an assessment of Navajo Route 59 in the Chilchinbeto region as a pivotal analysis for highway improvement and to be inclusive on all

recommendations and objective of the Navajo Department of Transportation and the Bureau of Indian Affair Road Department to rehabilitate and enhance a safe route.

# REQUESTING THE NAVAJO NATION DEPARTMENT OF TRANSPORTATION AND THE BUREAU OF INDIAN AFFAIRS- WESTERN NAVAJO AGENCY-BRANCH OF TRANSPORTATION TO CONDUCT A DRAINAGE STUDY ON BIA ROUTE N6486 AT PARRISH CREEK WASH CROSSING

#### WHEREAS,

- 1. Pursuant to 26 N.N.C., Section 3(A), the Kayenta Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., Section 10; and
- 2. Pursuant to 26 N.N.C., Section 1(B), the Kayenta Chapter is vested with the authority to review all matters affecting the community and to make appropriate correction(s) when necessary and make recommendation(s) to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. BIA Route N6486 is an earth dirt road located within the boundaries of the Kayenta Chapter; and
- 4. Environment and climate erosion factors, such as heavy rain, rain intensity, rain duration, and vegetation, play a major role in erosion in unsurfaced roads; and
- 5. Multiple attempts have been made in the past to replace damaged culverts at the Parrish Creek Crossing; and
- 6. A drainage study needs to be conducted for erosion control and put in drainage structures such as a box culvert.
- 7. The most recent rainstorm caused damage to the recently replaced culverts; and
- 8. The Navajo Nation Department of Emergency Management, the Navajo Nation Department of Transportation, and the Bureau of Indian Affairs- Western Navajo Agency Branch of Transportation were all notified of the road damage at Parrish Creek Crossing.

#### NOW THEREFORE BE IT RESOLVED THAT:

The Kayenta Chapter hereby requests the Navajo Nation Department of Transportation and the Bureau of Indian Affairs—Western Navajo Agency—Branch of Transportation to conduct a drainage study on BIA Route N6486 at Parrish Creek Wash Crossing, with reference to Exhibit "A," pictures of N6486 at Parrish Creek Crossing. Furthermore, the Kayenta Chapter strongly emphasizes the need for the design and construction of a more permanent and resilient drainage structure, such as a box culvert or similar reinforced system, to replace the existing standard culverts that have repeatedly failed or washed out during heavy rain events. This improvement is critical to ensure long-term roadway stability, public safety, and reliable community access.
